<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. This includes email, SMS, and any other form of communication.  <b>SMS opt-in or phone numbers are not being shared for the purpose of SMS.</b> <i>By opting into SMS from a web form or other medium, you are agreeing to receive SMS messages from Laurel Oak Wealth Management, LLC. This includes SMS messages for appointment scheduling, appointment reminders, post-visit instructions, and other general messages. Message frequency varies. Message and data rates may apply. <b>Definitions</b>	
<b>Affiliates</b>	<p>Companies are related by common ownership and control. They can be financial or nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ <i>We may share information with our affiliates for our everyday business purposes, including information about your transactions and experiences.</i></li> </ul>
<b>Nonaffiliates</b>	<p>Companies not related by common ownership and control. They can be financial or nonfinancial companies.</p> <ul style="list-style-type: none"> <li>▪ <i>We do not share with nonaffiliates so that they can market to you.</i></li> </ul>
<b>Joint marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>▪ <i>We do not jointly market.</i></li> </ul>

<b>Other important information</b>	
<p>SMS Terms &amp; Conditions</p> <ol style="list-style-type: none"> <li>1. SMS Consent Communication: The information (i.e. phone numbers) obtained as part of the SMS consent process will not be shared with third parties for marketing purposes.</li> <li>2. Types of SMS Communications: If you have consented to receive text messages from Laurel Oak Wealth Management, LLC, you may receive messages related to the following: appointment reminders, follow-up messages, billing inquiries. Example: "Hello, this is a friendly reminder of your upcoming appointment with your advisor at our office on 4/3/25 at Noon EST. Potential Fees for SMS Messaging: Please note that standard message and data rates may apply, depending on your carrier's pricing plan. These fees may vary if the message is sent domestically or internationally.</li> <li>5. Opt-In Method: You may opt in to receive SMS messages from Laurel Oak Wealth Management, LLC, in the following ways: By submitting an online form.</li> <li>6. Opt-Out Method: You can opt out of receiving SMS messages at any time. To do so, simply reply "STOP" to any SMS message you receive.
